LEGAL DESCRIPTION:

Commencing at the Southeast corner of the NW 1/4 of Section 22; thence N. $00^{\circ}46'35''$ E., along the East boundary of the NW 1/4, 523.49 feet to the true point of beginning of this description; thence N. $00^{\circ}46'35''$ E., along the East boundary of the NW 1/4, 799.29 feet to the Northeast corner of the SE 1/4 NW 1/4 of Section 22; thence N. $89^{\circ}42'55''$ W., along the North boundary of the SE 1/4 NW 1/4, 663.79 feet to the Northwest corner of the E 1/2 SE 1/4 NW 1/4; thence S. $00^{\circ}38'07''$ W., along the West boundary of the E 1/2 SE 1/4 NW 1/4, 158.07 feet; thence Southeasterly 85.60 feet along the arc of a 100.00 foot radius curve to the right (long chord = S. $76^{\circ}09'26''$ E. 83.01 feet); thence S. $51^{\circ}38'02''$ E., 170.98 feet; thence Southeasterly, 188.56 feet along the arc of a 560.00 foot radius curve to the right (long chord = S. $41^{\circ}59'17''$ E., 187.67 feet); thence S. $32^{\circ}20'31''$ E., 212.06 feet; thence Southeasterly, 225.56 feet along the arc of a 609.56 foot radius curve to the left (long chord = S. $42^{\circ}56'34''$ E., 224.28 feet); thence S. $53^{\circ}32'36''$ E., 60.00 feet to the true point of beginning.
