Cunningham, Case No. 0502725CV, in the Circuit Court of Oregon for the County of Klamath, a life estate interest for Jacob W. Cunningham with a remainder interest in Gary K. Cunningham on the condition that Jacob W. Cunningham predeceases Gary K. Cunningham, Grantees. If Jacob W. Cunningham survives Gary K. Cunningham, then Jacob W. Cunningham enjoys fee simple title. This vesting is for the following described real property, free of encumbrances except as specifically set forth herein:

A parcel of land situated in Section 8 of Township 39 South, Range 10 East of the Willamette Meridian, more particularly described as follows:




