The true and actual consideration for this conveyance is **\$40,000.00**.

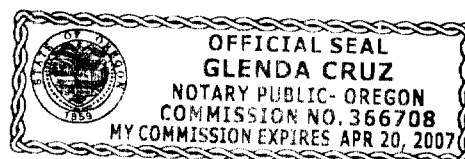
