## DECLARATION OF RESTRICTIVE COVENANT (Open Space)

THIS DECLARATION OF RESTRICTIVE COVENANT (this "Declaration") is made as of the /b day of November, 2005, by Running Y Resort, Inc., an Oregon corporation ("Declarant").

Declarant is the owner of certain real property located in Klamath County, Oregon, as more particularly described on the attached Exhibit A and depicted on the attached Exhibit B (the "Property") located within a destination resort named the Running Y Ranch developed by Declarant (the "Resort").

### NOW, THEREFORE, Declarant declares as follows:

- 1. <u>Open Space Covenant</u>. The Property shall be maintained as "open space" as that term is defined in Section 88.020.B of the Land Development Code of Klamath County or as that term may be defined in any future ordinance of Klamath County regulating the development of destination resorts.
- 2. <u>Duration and Nature of Declaration</u>. This Declaration shall continue in perpetuity. This Declaration is intended to and does attach to and run with the Property. This Declaration is binding on Declarant and all persons claiming under Declarant. It is the intent of Declarant to create a continuing obligation and right on the part of Declarant and subsequent owners of the Property only during their period of ownership.
- 3. Ownership. Declarant is the owner of the Property. If Declarant transfers the Property to a subsequent purchaser or purchasers, each such purchaser shall be bound by the terms of the Declaration.
- 4. <u>Modification or Termination</u>. The owner or owners of the Property may not withdraw from, modify or dissolve this Declaration except with the prior written approval and consent of Klamath County, Oregon, as evidenced by a written instrument recorded in the Official Records of Klamath County, Oregon.




