WHEREAS, Michael D. Alarcon entered into an agreement with Klamath County on May 13, 2004, for the purchase of real property described as:

The Easterly 24 feet of Lot 36 and the Westerly 20 feet of Lot 35, Roselawn, subdivision of Block 70, Buena Vista Addition To Klamath Falls, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon. Together with that portion of vacated alley which inured thereto.

Subject to covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.

WHEREAS, the property was purchased for the sum of \$24,000.00 and a down payment of \$6,000.00 was made the day of the sale with the sum of \$7,800.00 to be paid as the first annual installment due May 13, 2005; and

WHEREAS, Michael D. Alarcon failed to make the May 13, 2005, annual installment as required by Section 8 of the Land Sale Agreement. The installment and taxes are now in default under the terms of the Land Sale Agreement; and

WHEREAS, on June 30, 2005, a letter was mailed regular and certified to Michael D. Alarcon requesting the annual installment in the amount of \$8,184.66 and taxes in the amount of \$463.70 be paid in full by July 29, 2005, in order to avoid cancelling the Land Sale Agreement. WHEREAS, on August 17, 2005, a final notice was mailed regular and certified requesting the remaining balance, interest and recording fee in the amount of \$20,338.81 and taxes in the amount of \$469.41 be paid by August 25, 2005, in order to avoid cancelling the Land Sale Agreement.
