## **GENERAL EASEMENT AGREEMENT**

## DESCRIPTION FOR DRIVEWAY EASEMENT

A parcel of land situated in the NE1/4 of the NW1/4 of Section 6, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon being a portion of Lot 30 of Tract 1316 – Paradise Hill as on file in the records of Klamath County, Oregon, and more particularly described as follows:
