QUITCLAIM DEED

This Quitclaim Deed, executed this 20th day of December, 2005,

WITNESSETH, that the said Grantors, for good consideration and for the sum of \$1.00 (one dollar) paid by the said Grantee, the receipt whereof is hereby acknowledged, does hereby remise, release, and quitclaim unto said Grantee forever, all the right, title, interest, and claim which the said Grantors have in and to the following described parcel of land, and improvements and appurtenances thereto in the County of Klamath, State of Oregon, To Wit:

An undivided one-half interest in the following described real property, situated in the County of Klamath, State of Oregon:

PARCEL 1: The SW ¼ NE ¼ of Section 35, Township 34 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.

PARCEL 2: The SE ¼ NE ¼ of Section 35, Township 34 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.

PARCEL 3: That part of the NE ¼ of the SW ¼ that lies North of the Sprague River Highway, in Section 35, Township 34 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.

EXCEPTING that portion described as follows:

Beginning at the C-W 1/16 corner of said Section 35; thence North 89° 11' 19" East along the North line of the NE ¼ of the SW ¼ of said Section 35 a distance of 191.97 feet; thence leaving said line, South 09° 34' 41" West 158.58 feet; thence South 29° 15' 22" West 88.68 feet to a point on the Northeasterly right of way line of Sprague River Road; thence North 64° 53' 27" West, along said Northeasterly right of way line, 135.00 feet to a point on the West line of the NE ¼ of the SW ¼ of said Section 35; thence North 00° 00' 19" East 173.73 feet to the point of beginning.
