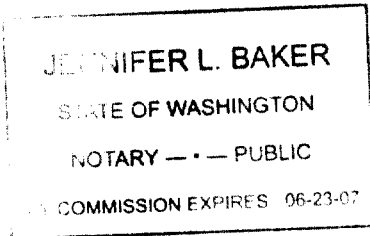

AMENDED TRUSTEE'S NOTICE OF SALE
