NOTICE OF DEFAULT AND ELECTION TO SELL

Pursuant to O.R.S. 86.705 et seq. and O.R.S. 79.5010, et seq.

Reference is made to that certain trust deed made, executed, and delivered by Nancy Mata, as Grantor, to U.S. Bank of Washington, National Association, as Trustee, to secure certain obligations in favor of U.S. Bancorp Mortgage Company, as Beneficiary, dated June 8, 1992, and recorded on June 15, 1992, in the Mortgage records of Klamath County, Oregon, in Vol No. M92, Page No. 12910. The beneficial interest under said Trust Deed and the obligations secured thereby are presently held by Oregon Housing and Community Services Department, State of Oregon by assignment of deed of trust recorded on June 15, 1992, in the Mortgage records of Klamath County, Oregon in Vol. No. M92, Page No. 12916. Said Trust Deed encumbers the following described real property situated in said county and state, to-wit:

The undersigned successor trustee, Joseph A.G. Notice is further given that any person named in ORS 86.753 has the right, at any time prior to five days before the date last set for the sale, to have this foreclosure proceeding dismissed and the trust deed reinstated by payment to the beneficiary of the entire amount then due (other than such portion of the principal as would not then be due had no default occurred) and by curing any other default complained of herein that is capable of being cured by tendering the performance required under the obligation or trust deed, and in addition to paying said sums or tendering the performance necessary to cure the default, by paying all costs and expenses actually incurred in enforcing the obligation and trust deed, together with trustee's and attorney's fees not exceeding the amounts provided by said ORS 86.753. Notice is also given that any person named in ORS 86.753 has the right to bring a court action to assert the non-existence of a default or any other defense to acceleration and sale.
