FOR VALUE RECEIVED, the undersigned, who is the personal representative of the Estate of Edison Philmore Chiloquin, who is the beneficiary under that certain SPECIAL TRUST DEED dated February 22, 1985, executed and delivered by the United States of America, acting by and through the Forest Service, Department of Agriculture, Grantor, in favor of EDISON CHILOQUIN, as grantee ("Grantee") and beneficiary, recorded March 19, 1985, in Volume M85, Page 4052 of the Deed Records of Klamath County, Oregon, thereby reserving and setting aside unto the Grantee, his heirs and assigns, the beneficial use and occupancy in and to that certain parcel of land situated in the County of Klamath, State of Oregon, and described as follows, to-wit:

hereby grants, assigns, transfers, and sets over to DEANNA WILSON (hereinafter called "Assignee"), and Assignee's heirs, personal representatives, successors and assigns, all of the beneficial interest in and under said SPECIAL TRUST DEED, together with all rights and benefits whatsoever accrued or to accrue under said SPECIAL TRUST DEED.

The undersigned hereby covenants to and with the Assignee that the undersigned is the personal representative of the Estate of Edison Philmore Chiloquin, the beneficiary under said SPECIAL TRUST DEED, and is the owner and holder of the beneficial interest therein and has the right to transfer and assign the same.
