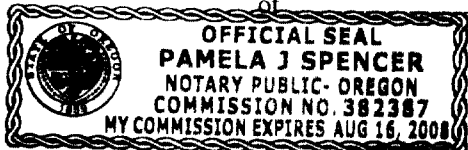

Description of Property Being Conveyed by Parcel 1 to Parcel 2
