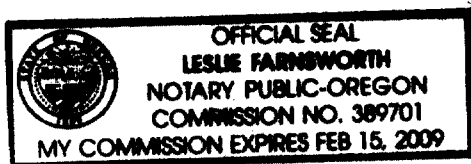



DEED OF FULL RECONVEYANCE

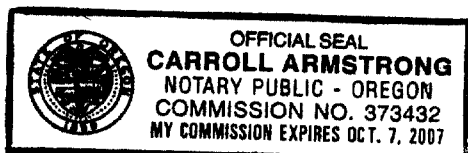
