
1. A description of the ownership and uses of the property proposed to be vacated; and

MAYWOOD DRIVE VACATION DESCRIPTION

A portion of Maywood Drive situated in the NE1/4 NE1/4 of Section 9, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, said portion of Maywood Drive being that 60 foot wide strip adjacent to Lot 4, Block 2 and Lot 5, Block 1 of Tract 1249, according to the official plat thereof on file in the Klamath County Clerks Office, said portion being more particularly described as follows:

Beginning at the southeast corner of said Lot 4, Block 2; thence N.00°02'00"W., 165.00 feet along the west right-of-way line of Maywood Drive, to the northeast corner of said Lot 4, Block 2; thence N.89°58'00"E., 60.00 feet to the northwest corner of said Lot 5, Block 1; thence S.00°02'00"E. along the east right of way line of Maywood Drive, a distance of 165.00 feet to the southwest corner of said Lot 5, Block 1; thence S.89°58'00"W., 60.00 feet to the Point of Beginning. Containing 9,900 square feet more or less, with bearings based on the Plat of Tract 1249.
