WHITNESSETH

- 1. Lessor hereby leases and demises unto Lessees all that farm situate in Klamath County, Oregon, and described as follows:
 - A. A piece or parcel of land containing 257.1 acres, more or less, and being portions of the West half (W½) of Section 17, and the East Half of the East Half (E½ E½) of Section 18, T. 39 S., R. 11 E., W.M. situate in Klamath County, Oregon, and more particularly described as follows:

Beginning at the section corner common to Sections 17, 18, 19, and 20, T. 39 S., R. 11 E., W.M., and running thence Westerly along the section line marking the southerly boundary of the said Section 18, thirteen hundred twenty feet, more or less, to a point in the center line of the county road along the Westerly boundary of the said East Half of the East Half (E1/2 E1/2) of the said Section 18, thence North, along the said center line of the said county road 5027.5 feet, more or less, to the center line of the Buck Creek Channel, as the same is now located and constructed; thence following the said center line of the Buck Creek Channel as the same is now located and constructed N. 89° 31' E. 116.9 feet; thence S. 57° 29' E., 2632.0 feet; thence S. 58° 16' E. 1000 feet, more or less, to a point in the center line of the present channel of Buck Creek; thence following the said center line of the present channel of Buck Creek southeasterly 650 feet, more or less, to its intersection with the Northwesterly or right bank of Lost River; thence following said Northwesterly or right bank of Lost River Southwesterly or downstream 3650 feet, more or less, to its intersection with the section line marking the Southerly boundary of the said Section 17; thence Westerly along the said section line 220 feet, more or less, to the said point of beginning.
