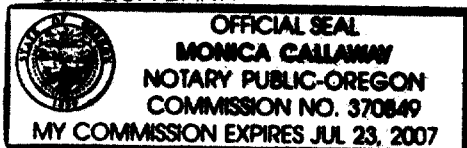





DEED OF FULL RECONVEYANCE

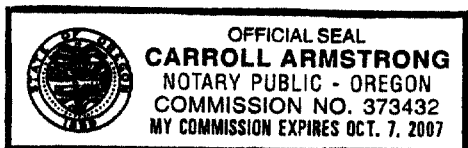


