



REVISED LEGAL DESCRIPTION OF: R5

TAX LOT 3809-33DC 12000, 12100

A parcel of land situated in the SW1/4 SE1/4 of Section 33, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being a portion of Lots 10, 11 and 12, Block 208 of Mills Second Addition to the City of Klamath Falls, as recorded at the Klamath County Clerks Office, being more particularly described as follows:




EXHIBIT MAP
