TERMINATION OF ENCROACHMENT PERMIT AGREEMENT RECORDED AT VOLUME M82, PAGES 6887-6888

On May 18, 1982, the City of Klamath Falls, Oregon ("City") granted the Klamath Falls Creamery permission to encroach into the air space over the Klamath Avenue public right-of-way between Lot 8, Block 10 and Lot 2D, Block 4, both in the Railroad Addition to the City of Klamath Falls according to the official plat thereof on file in the records of Klamath County, Oregon. An "Encroachment Permit Agreement" ("Agreement") setting forth the terms of the encroachment was recorded in the deed records of Klamath County at M82, pages 6887-6888.

KB Brewing, Inc. ("KB Brewing") is the current owner of Lot 8, Block 10 and is a successor in interest of the original Grantee, Klamath Falls Creamery. KB Brewing no longer has need for such encroachment and the City and KB Brewing intend by this document to terminate the Agreement.

NOW, THEREFORE, in consideration of the foregoing recitals, and pursuant to the terms of the Agreement, City and KB Brewing hereby terminate the Agreement recorded at M82, pages 6887-6888, the effect of said termination being that the permission to encroach into the air space above Klamath Avenue is hereby revoked and KB Brewing and its heirs, successors and assigns no longer have any right to encroach in said air space.
