### PERSONAL REPRESENTATIVE'S DEED

THIS INDENTURE Made this 5th day of May, 2006, by and between **MARVIN DEAN WALKER** the duly appointed, qualified and acting personal representative of the estate of **VINA AGNES WALKER**, deceased, hereinafter called the first party, and **DENNIS MURPHY and SHIREEN MURPHY**, as **tenants by the entirety**, hereinafter called the second party; WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situate in the County of Klamath, State of Oregon, described as follows, to-wit:

TO HAVE AND TO HOLD the same unto the said party, and second party's heirs, successors-in-interest and assigns forever.

The true and actual consideration paid for this transfer, stated in terms of dollars is \$70,000.00. However, the actual consideration consists of or includes other property or value given or promised which is part / whole of the consideration.

IN WITNESS WHEREOF, the said first party has executed this instrument; if first party is a corporation, it has caused its name to be signed and its seal affixed by an officer or other person duly authorized to do so by order of its board of directors.

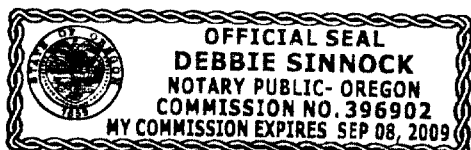

**EXHIBIT "A"**  
**LEGAL DESCRIPTION**

**PARCEL 1:**

Beginning at a point on the North right of way line of the County Road which lies South 89° 33' West a distance of 1360.3 feet and North 0° 27' West a distance of 30 feet from the iron axle which marks the Southeast corner of the NE1/4 NE1/4 of Section 25, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County Oregon, and running thence; South 89° 33' West along the Northerly right of way line of the County Road a distance of 79 feet to a point; thence North 0° 27' West a distance of 276.3 feet to a point; thence North 89° 33' East a distance of 79 feet to a point; thence South 0° 27' East a distance of 276.3 feet, more or less, to the point of beginning.

**PARCEL 2:**

Beginning at a point on the North right of way line of the County Road which lies South 89° 33' West a distance of 1439.3 feet and North 0° 27' West a distance of 30 feet from the iron axle which marks the Southeast corner of the NE1/4 NE1/4 of Section 25, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County Oregon, and running thence; South 89° 33' West along the Northerly right of way line of the County Road a distance of 79 feet to a point; thence North 0° 27' West a distance of 276.3 feet to a point; thence North 89° 33' East a distance of 79 feet to a point; thence South 0° 27' East a distance of 276.3 feet, more or less, to the point of beginning.
