LEGAL DESCRIPTION:

A portion of the S $\frac{1}{2}$ N $\frac{1}{2}$ of Section 30, Township 39 South, Range 9 East of the Willamette Meridian, in the County

of Klamath, State of Oregon, more particularly described as follows:

Beginning at a point on the Northwesterly right of way line of the Klamath Falls-Weed Highway in the S V_2 N V_2 of Section 30, Township 39 South, Range 9 East of the Willamette Meridian, which point of beginning is North, 1320 feet; thence South 89°44′ West along the South line of the NE V_4 SW V_4 of said Section 30, a distance of 1015.0 feet to the Northwesterly right of way line of said highway, and thence North 36°34′ East, along said highway right of way line, a distance of 1719.6 feet from the one quarter corner common to Sections 30 and 31 of said Township and Range; thence North 53°26′ West 414.6 feet, more or less, to the Southeasterly right of way line of the Southern Pacific Railroad; thence North 33°38′ East, 485.6 feet along said railroad right of way line; thence South 53°26′ East 464.5 feet, more or less, to the Northwesterly right of way line of said highway; thence along said highway right of way line as follows: South 36°34′ West, 412.43 feet, North 53°26′ West, 25.0 feet and South 36°34′ West, 72.57 feet to the point of beginning.
