MEMORANDUM OF LAND SALE AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that on June 1, 2006, **Klamath County**, a Political subdivision of the State of Oregon, as vendor and **Richard R. Hamilton & Sandra S. Hamilton, as Tenants by the Entirety**, as vendee(s) made and entered into a certain Land Sale Agreement wherein said vendor agreed to sell to said vendee(s) and the latter agreed to purchase from said vendor the fee simple title in and to the following described real property in Klamath County, State of Oregon, to-wit:

In Witness Whereof the said vendor has executed this Memorandum June 7, 2006.

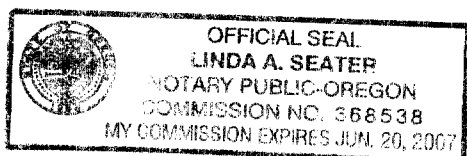
