In Witness Whereof the said vendor has executed this Memorandum June 7, 2006.

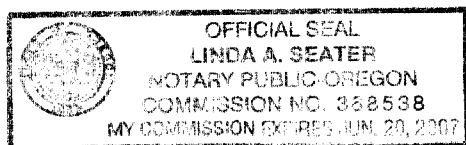
