QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Mike N. Kincade, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Beginning at the South one-quarter corner of Section 36, Township 24 South, Range 8 East of the Willamette Meridian; thence N 0° 32' E along the North-South center section line 881.76 feet; thence S 89° 15' E 1008.2 feet; thence N 120 feet to the true point of beginning; thence S 89° 15' E 313.72 feet to the West right of way line of State Hwy No. 97; thence N 24° 52' E along the West right of way line of State Hwy No. 97, 5.48 feet; thence N 89° 15' W 315.96 feet; thence S 5.00 feet to the point of beginning.

Subject to covenants, conditions, restrictions, easements, reservations, rights, rights of way and all matters appearing of record.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.

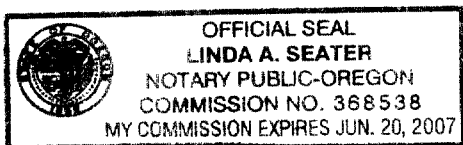

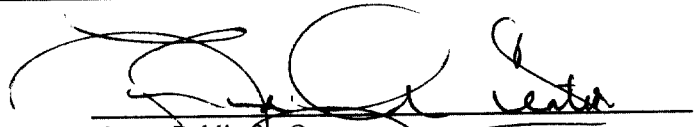
