EXHIBIT A

LEGAL DESCRIPTION:

The Easterly 6 feet of Lot 3 and the Westerly 34 feet of Lot 2, both in Block 7, First Addition of the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, more particularly described as follows:
