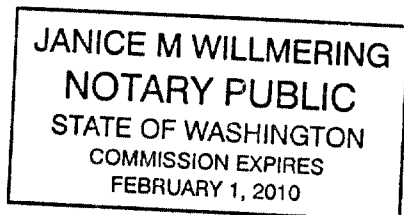

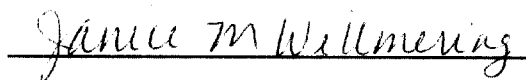

DEED OF RECONVEYANCE

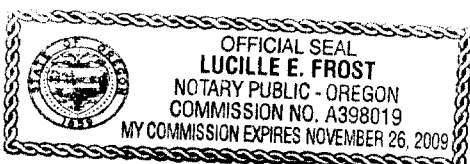
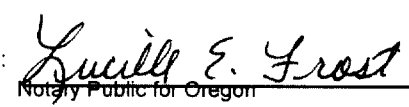
