The true and actual consideration for this transfer is **\$126,500.00**.

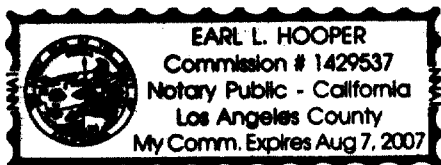


