## **EXHIBIT A**

## LEGAL DESCRIPTION:

Parcel 1: All that portion of the SW 1/4 SE 1/4 of Section 2, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, which lies South of the right of way of the O. C. & E. Railway Company, less any portion thereof contained in roadway, and Less portion described as follows: Beginning at an iron pipe at the most Westerly corner of Tract 1 of Homedale; thence N. 76 feet, more or less, to the Southerly line of the right of way of the O. C. & E. Railway; thence Southeasterly along the Southerly right of way line of said Railway, 192 feet, more or less, to the South boundary line of the SW 1/4 SE 1/4, said Section 2; thence West along said South line a distance of 176 feet 6 inches, more or less to the point of beginning.

Parcel 2: All that portion of the SW 1/4 SE 1/4 Section 2, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows: Beginning at an iron pipe at the most Westerly corner of Tract 1, Homedale; thence N. 76 feet, more or less, to the Southerly line of the right of way of the O. C. & E. Railway; thence Southeasterly along the Southerly right of way line of said Railway, 192 feet, more or less, to the South boundary line of the SW 1/4 SE 1/4 said Section 2; thence West along said South line a distance of 176 feet 6 inches, more or less, to the point of beginning.

Parcel 3: Beginning at an iron pin at the most Westerly corner of Tract No. 1, Homedale; thence Southeasterly along the Northerly boundary line of 2nd Avenue of Homedale a distance of 160 feet to a point on said boundary line; thence Northerly to an iron pipe distant 182.84 feet S. 89°48' E. from the most Westerly corner of said Tract; thence Westerly along the Northerly boundary line of said Tract, 182.84 feet to the point of beginning, being a triangular piece of land out of the Westerly portion of said Tract No. 1.
