MTC1394-8043 DEED, ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS DEED, ASSIGNMENT AND ASSUMPTION AGREEMENT (this "<u>Assignment</u>") is made as of September 6, 2006 (the "Effective Date"), by and between Peoples Energy Resources Company, LLC, a Delaware limited liability company ("<u>Assignor</u>") and COB Energy Facility, LLC, a Delaware limited liability company ("<u>Assignee</u>").

RECITALS

Upon the Effective Date, Assignor does hereby grant, convey, quitclaim and assign to Assignee all of Assignor's rights and obligations under the Option Agreements, including without limitation, rights to all easements granted therein and all rights to extension thereof, if any.
- 2. <u>Assumption of the Option Agreements</u>. Upon the Effective Date, Assignee hereby accepts and assumes the rights and obligations of Assignor under the Option Agreements and does hereby assume, become fully responsible for, and agree to perform, discharge, fulfill, and observe all of the obligations, covenants, and conditions with respect to the Option Agreements arising from and after the date hereof.
- 3. <u>Governing Law</u>. This Assignment shall be governed by the laws of the State of Oregon without regard to its choice of law provisions.
