another person duly organized to do so by order of its Board of Directors.

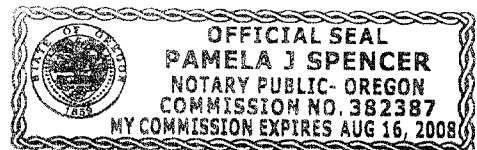
