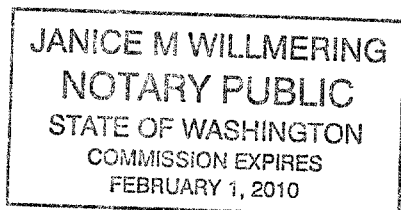

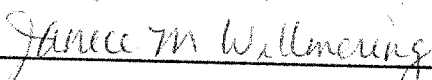

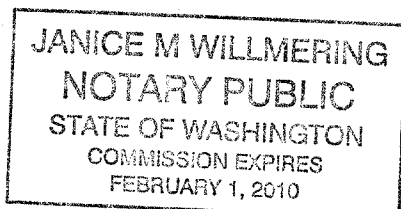
DEED OF RECONVEYANCE

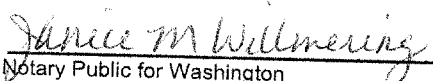
