Exhibit "A"

A portion laying in the SW 1/4 of the NW 1/4, Section 31, Township 24 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

BEGINNING at an iron pin on the Easterly right of way line of The Dalles-California Highway, which lies North along the West section line distance of 793.7 feet and North $29^{\circ}02'$ East along the Easterly right of way line of The Dallas-California Highway a distance of 110 feet from the iron pin which makes the West quarter corner of Section 31, Township 24 South, Range 9, East of the Willamette Meridian, Klamath County, Oregon, running thence; continuing North $29^{\circ}02'$ East along the Easterly right of way line of The Dalles-California Highway a distance of 100 feet to a point; thence South $60^{\circ}58'$ East at right angles to the highway center line a distance of 100 feet to a point; thence South $29^{\circ}02'$ West parallel to the highway center line a distance of 100 feet to a point; thence North $60^{\circ}58'$ West a distance of 100 feet, more or less.
