LEGAL DESCRIPTION:

Lot 17 and the Westerly 13 feet of Lot 16 (being a portion of Lot 16 lying between the Northwesterly line thereof and a line parallel thereto and distance 13 feet Easterly and extending between Prescott Street and Oregon Avenue) in Block 72 of Buena Vista Addition to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.
