RESCISSION AND RELINQUISHMENT OF UTILITY EASEMENT DEDICATED ON BLOCK 3, LOT 8 OF "CASCADE PARK" SUBDIVISION AS RECORDED IN THE RECORDS OF THE KLAMATH COUNTY CLERK ON DECEMBER 13, 1961

RECITALS

- A. On December 13, 1961 the Klamath County Clerk accepted for recording the plat map and dedication page for "Cascade Park" (the "Subdivision").
- B. The map as mentioned above states that the owners of the subdivision, G.E. and Phyllis Rutledge, "do for themselves, their transferees, successors and assigns, hereby dedicate, donate, and convey to the public use forever, all streets, said plat being subject to: easement along the back and side lines of lots as shown on the annexed plat for present and future utilities, irrigation, and drainage, said easements to provide ingress and egress for construction and maintenance of said utilities with no permanent structure being permitted thereon and any plantings being placed thereon at the risk of the owner. The Subdivision plat dedicates a sixteen foot (16') wide utility easement along the easterly border of Lot 8 of Block 3 of the Subdivision."
- C. A 60-foot wide strip of land crossing said Lot 8, and thus crossing the utility easement has been dedicated to Klamath County as public right-of-way (as shown in Exhibit "A") and the County desires that said right-of-way not be burdened by the easement.

RESCISSION AND RELINQUISHMENT OF DEDICATED UTILITY EASEMENT, BLOCK 3 LOT 8 "CASCADE PARK"

In consideration of the foregoing recitals, the City of Klamath Falls, Oregon, on behalf of the public, does hereby rescind and relinquish that certain 16-foot wide utility easement dedicated on Block 3, Lot 8 of the plat map for "Cascade Park" as recorded in the records of the Klamath County Clerk on December 13, 1961. The easement being rescinded and relinquished is legally described and depicted on Exhibit "A."
