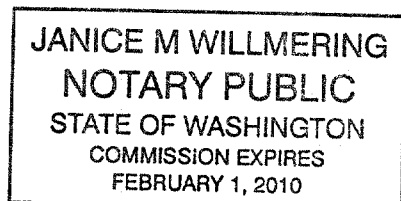

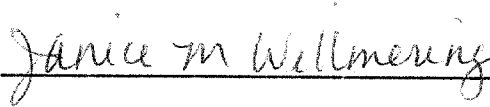

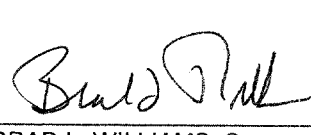

DEED OF RECONVEYANCE

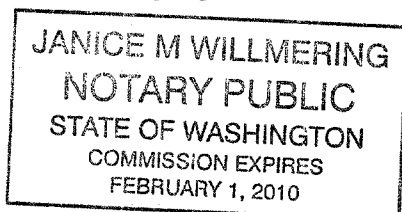

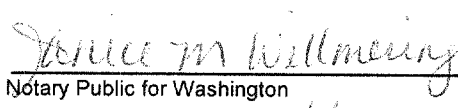
