(b) on the date I am adjudged incompetent by a court of proper jurisdiction.

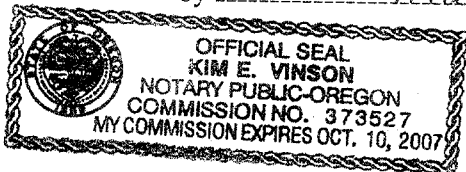
If neither phrase is deleted, this power shall take effect on the date next written below.
