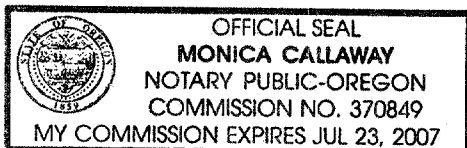

DEED OF FULL RECONVEYANCE

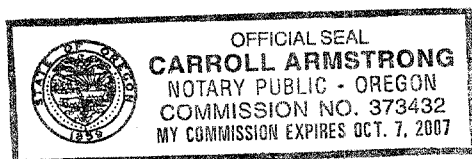
