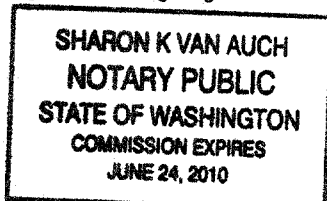
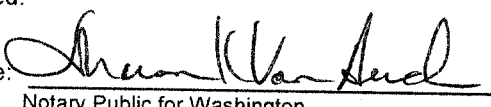
DEED OF RECONVEYANCE
