NOW, THEREFORE, IT IS HEREBY ORDERED that the petition is granted and that the portion described herein is vacated, as said vacation in the public interest.

IT IS HEREBY ORDERED that the costs resulting from the approved vacation is determined to be in the sum of \$100.00 and that the persons liable for payment of the costs are the petitioners, who have paid the above mentioned sum on Sept 26, 2006.
