Both the beneficiary and the trustee have elected to sell the real property to satisfy the obligations secured by the trust deed and a notice of default has been recorded pursuant to Oregon Revised Statutes 86.735(3); the default for which the foreclosure is made is grantor's failure to pay when due the following sums: monthly payments of \$632.64 beginning 10/01/05; plus late charges of \$26.65 each month beginning 10/16/05; plus prior accrued late charges of \$159.90; plus advances of \$148.00; plus previous servicer expenses of \$546.78; plus escrow shortages of \$5921.13; together with title expense, costs, trustee's fees and attorney's fees incurred herein by reason of said default; any further sums advanced by the beneficiary for the protection of the above described real property and its interest therein; and prepayment penalties/premiums, if applicable.
