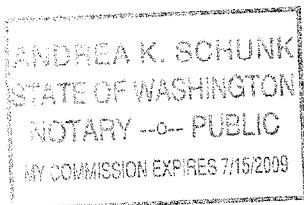

DEED OF RECONVEYANCE

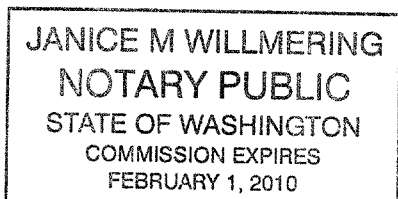
