LEGAL DESCRIPTION:

Parcel 1:

A parcel of land situate in the SW 1/4 SW 1/4 of Section 30, Township 24 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, lying on the East side of U. S. Highway 97, more particularly described as follows:

Beginning at a point along the South line of Section 30, from which the West 1/16 corner common to Sections 30 and 31 bears South 89°04'28" East 115.86 feet; thence along said South section line, North 89°04'28" West 219.49 feet to a point along the East line of U. S. Highway 97 and 50 feet from the centerline thereof; thence along the East line of said U. S.
