

EXHIBIT "A" LEGAL DESCRIPTION

A parcel of land, being a portion of the SE1/4 SW1/4 of Section 30, Township 24 South, Range 9 Fast of the Willamette Meridian, Klamath County, Oregon, the said parcel of land being described as

Beginning at a point on the Bast boundary of the right-of-way of The Dalles-California Highway, the said point being marked by a 1/2 inch iron rod, said point being further located North 732 feet and Bast 1331 feet from the Southwest corner of Section 30, Township 24 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon; thence North 30° 30' East 16.89 feet; thence on a curve to the right, the said curve having a radius of 2814.8 feet for a distance of 140.7 feet (the chord of said curve having a bearing of North 31° 17' East and a length of 140.70 feet), along the Easterly boundary of said South 30° 22' West 152.56 feet to a point marked by an iron rod; thence to the point of beginning.

ALSO a tract of land located in the SE1/4 SW1/4 of Section 30, Township 24 South, Range 9 East of the Willamette Meridian, Klamath County, Orogon, more particularly described as follows:
