The true and actual consideration for this conveyance is Gift.

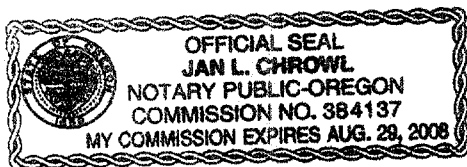

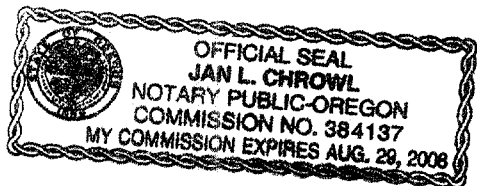
