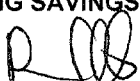
APPOINTMENT OF SUCCESSOR TRUSTEE

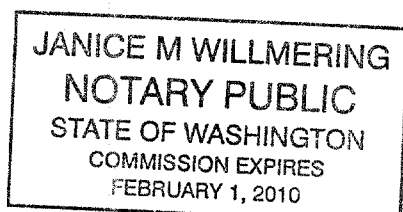
DEED OF RECONVEYANCE

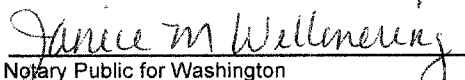
