This Modification of Leasehold Deed of Trust, Security Agreement and Fixture Filing with Assignment of Rents ("Modification") is made as of this 29^{+h} day of January, 2007, by Plum Ridge Care Community, LLC, an Oregon limited liability company, ("Trustor" or "Debtor"), to First American Title Insurance Company ("Trustee"), for the benefit of Vestin Mortgage, Inc. as assigned to Vestin Fund I, LLC, a Nevada limited liability company, Vestin Fund II, LLC, a Nevada limited liability company, and Vestin Fund III, a Nevada limited liability company (Vestin Fund I, LLC was succeeded in merger by Vestin Realty Mortgage I, Inc., a Maryland corporation and Vestin Fund II, LLC was succeeded in merger by Vestin Realty Mortgage II, Inc. a Maryland corporation)(collectively, "Beneficiary" or "Secured Party").

RECITALS

- This Modification modifies the Leasehold Deed of Trust, Security Agreement and Fixture Filing with Assignment of Rents made on July 15, 2005, and recorded in the Official Records of Klamath County on July 20, 2005, under recording number M05-55677, under which Trustor is the trustor, Beneficiary is the beneficiary and First American Title Insurance Company is the Trustee (the "Deed of Trust"). The Deed of Trust covers the real property described in Exhibit A attached hereto.
- The Trustor and Beneficiary wish to modify the Deed of Trust in order to reflect that the maximum amount secured thereby has been increased from \$4,600,000.00 to \$5,512,000.00.

 - 2. The maximum principal amount of the loan is amended to be \$5,512,000.00.
- 3. All terms and conditions of the Deed of Trust not expressly modified herein remain in full force and effect, without waiver or amendment. This Modification and the Deed of Trust shall be read together, as one document. The real property described in the Deed of Trust shall remain subject to the lien, charge or encumbrance created in the Deed of Trust and, except as expressly stated herein, nothing herein contained or done pursuant to this Modification shall affect or be construed to affect the liens, charges or encumbrances created in the Deed of Trust, or the priority thereof over other liens, charges or encumbrances, or to increase or affect the liability of any party or parties who may now or hereafter be liable under or on account of the Deed of Trust.

EXHIBIT A Property Description

Real property in the City of Klamath Falls, County of Klamath, State of Oregon, described as follows:

A tract of land situated in the SW 1/4 of the NE 1/4 of Section 20, Township 38 South, Range 9 East, Willamette Meridian, Klamath County, Oregon, being a portion of Blocks 7 and 8 and vacated Hilltop Street, McLoughlin Heights Subdivision, more particularly described as follows:

Commencing at the Northeast corner of McLoughlin Heights; thence South 00°46'00" West, along the East boundary of McLoughlin Heights, 100.0 feet to the true point of beginning of this description; thence South 0°46'00" West, along the East boundary of McLoughlin Heights 572.30 feet to the North boundary of Foothills Boulevard; thence 40.57 feet along the arc of a 20.00 foot radius curve to the right (the long chord of which bears South 58°53' West, 33.97 feet); thence North 63°00'00" West, along the North boundary of Foothills Boulevard, 104.35 feet; thence 482.81 feet along the arc of a 774.83 foot radius curve to the left (the long chord of which bears North 80°51'03" West, 475.03 feet); thence leaving said road boundary North 20°39'40" East, 504.11 feet; thence South 89°21'00" East, 420.87 feet to the true point of beginning.
