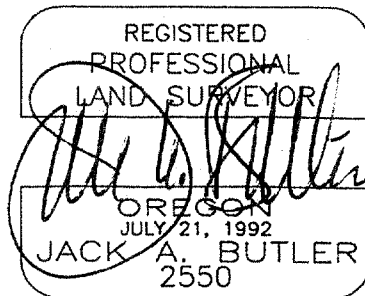

THENCE 12.00 FEET LEFT AND RIGHT OF THE FOLLOWING DESCRIBED CENTERLINE: LEAVING SAID SOUTHEASTERLY LINE NORTH 31°45'09" WEST 45.00 FEET TO THE SOUTHEASTERLY LINE OF LOT 1311 AND THE POINT OF TERMINATION.

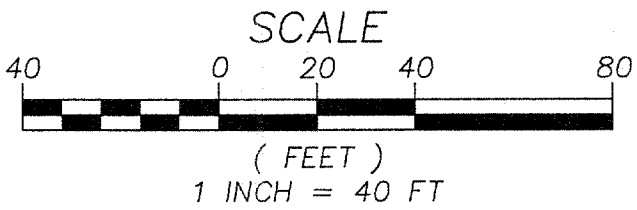
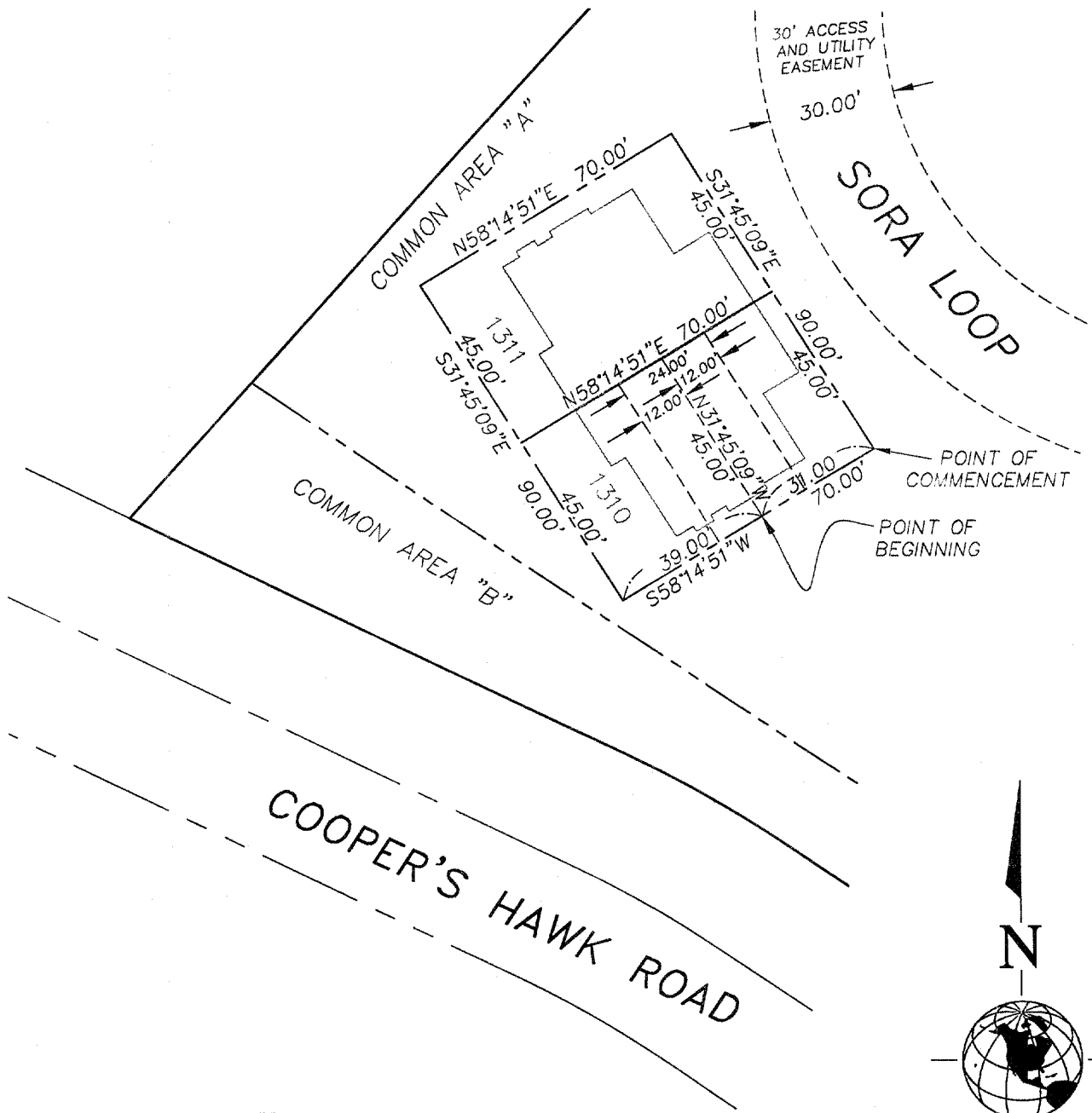
