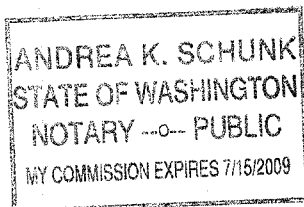

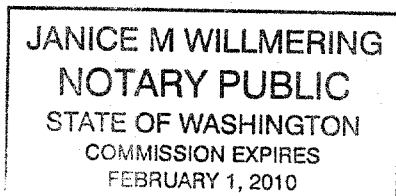
DEED OF RECONVEYANCE
