LEGAL DESCRIPTION

The S1/2 of the following described property in Klamath County, Oregon:

A parcel of land situated in the SW1/4 of Section 9, Township 39 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at a 1/2 inch iron pin marking the Northeast corner of said SW1/4; thence South along the East line of said SW1/4, 1268.97 feet to a 1/2 inch iron pin on the Westerly right-of-way of Pine Grove Road, a county road; thence Southwesterly along said right-of-way line (long chord – South 14° 37' 27" West, 64.82 feet) to a 1/2 inch iron pin at the intersection of said right-of-way line with the South line of the NE1/4 of said SW1/4; thence North 89° 48' West along said South line of NE1/4 SW1/4, 313.44 feet to a 1/2 inch iron pin marking the Southwest corner of the E1/2 E1/2 of said NE1/4 SW1/4; thence North 0° 6' 40" East along the West line of said E1/2 E1/2 NE1/4 SW1/4; thence South 89° 6' 22" East along the North line of said SW1/4, 327.25 feet to the point of beginning.
