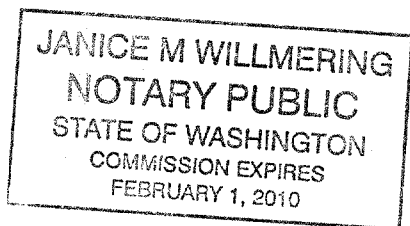

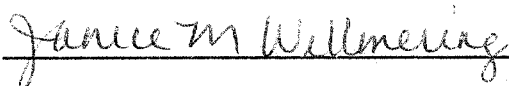

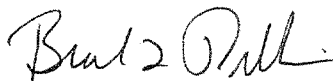

DEED OF RECONVEYANCE

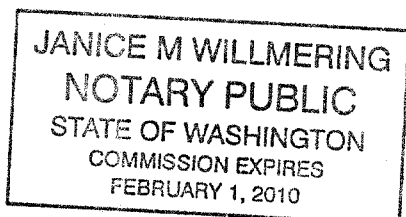
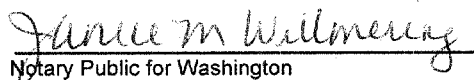
