### Amendment to Easement Section Three Of Easement Recorded On

NOW, THEREFORE, in view of the premises and in consideration of \$0.00 by the second party to the first party paid, the receipt of which is acknowledged by the first party, it is agreed:

The first party hereby grants, assigns and sets over to the second party a driveway easement, to-wit:

Beginning at the property line located at the driveway entrance of the first party's property, off State Highway 70, and continuing northwardly approximately 24 feet to the end of the electric pole guy wire, then turning approximately at a 90-degree angle, and continuing approximately 38'2" in a eastwardly angle to the second party's party line. Then, continuing northwardly approximately 20 feet further to where the northwardly easement shall end.

Thence, turning at a 90-degree angle eastwardly, off the main driveway, a distance of approximately 38' 2" to the second party's property line creating a permanent driveway easement into the second party's property, which shall be 20 feet wide by 38' 2" long, which section shall be maintained solely by the second party. (See attachment "A" for reference.)


Both parties shall be responsible for the first 44 feet of main driveway maintenance, which is used by both parties. Both parties shall share equally in the cost required to maintain or upgrade said 44 feet of main driveway.

This easement shall continue until such time as the second party applies for, and is granted, a private driveway to their real property from the Oregon Department of Transportation. At that time, the parties shall jointly agree to abandon this easement.





Photo 2: Proposed driveway assess to second party's property
