2. GOLF SAVINGS BANK referred to herein as "lender" is the owner and holder of the deed of trust dated 3-14-07 executed by RUSSELL C. CARTER & JODY A. CARTER under auditor's file No. records of Klamath County (which is to be recorded concurrently herewith).

3. **Russell C. Carter & Jody A. Carter**, referred to herein as "owner", is the owner of all the real property described in the deed of trust identified above in Paragraph 2.

4. In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its deed of trust and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of the deed of trust identified in Paragraph 1 above to the lien of "lender's" deed of trust identified in Paragraph 2 above, and all advances or charges made or accruing thereunder, including any extension or renewal thereof.

5.
